



## ***Crime Bulletin and District Update***

On 12/01/2017 Officers responded to the 400 block of A Street on a report of a package theft.

On 12/06/17 Officer Yanga responded to a hit and run collision at 87<sup>th</sup> Street and Nimitz Drive. Officers are looking for a white or grey vehicle with front passenger side damage.

On 12/07/17 Officer Morton responded to a missing persons call. The subject was last seen at the Motorville Motel and was deemed at risk. The investigation is ongoing.

On 12/17/17 Officer Segali and Logan contacted a subject at Colma Bart. Upon contact, the subject attempted to discard a loaded firearm and narcotics. Upon inspection, it was discovered that the serial number on the firearm had been removed. The subject was arrested.

On 12/18/17 Officer Yanga was on patrol when he conducted a traffic enforcement stop. Following a records check on the driver, it was discovered that he had an outstanding felony warrant for \$35,000.00 for auto burglary, possession of burglary tools and grand theft. The driver was arrested and later booked into the County Jail.

On 12/18/17 Officer Segali and Logan were on patrol in the area of El Camino Real and F Street when they conducted a bicycle stop for vehicle code violations. A subsequent search of the subject revealed he was in possession of narcotics. The subject was arrested and issued a citation.

On 12/18/17 Officer Segali and Logan conducted a traffic enforcement stop on a vehicle for making an unsafe turning movement. Upon contact, the driver became uncooperative and had to be taken out from the vehicle. Following an arrest, officers located "brass knuckles". The subject was arrested and later booked into the County Jail.

On 12/19/2017 between 2100 – 2130 hours, a 2000 Honda Civic was stolen on Reiner Street. The vehicle was later recovered by the San Francisco Police Department.

On 12/24/2017 at approximately 0930 hours, numerous vehicles on the 1700 and 1800 block of Sweetwood Drive were vandalized. Anyone with information on the suspect (s) is encouraged to contact the Police department.

On 12/24/2017 Officers responded to the 200 block of F Street on a report of a domestic violence. The investigation is ongoing and has been forward to the District Attorney's office.

On 12/25/2017 Officers responded to the La Terraza apartments located at 7800 El Camino Real in Broadmoor on a report of a domestic disturbance. Following an investigation, an arrest was made for domestic violence.

On 12/30/2017 the Broadmoor Police Department assisted the Colma Police Department with a disturbance at the Lucky Chances Casino. Upon arrival, the person causing the disturbance began making incoherent statements. The subject was later transported to Mills Peninsula.
