

Crime Bulletin and District Update (March 2018)

On 03/01/2018, a traffic enforcement stop was conducted at the intersection of A St. and Second Ave. The driver was found to be driving without a valid driver's license, arrested and issued a citation.

On 03/02/2018, BPD responded to a robbery that occurred a couple days prior on 02/27/18. The suspect stole property from the victim.

On 03/03/2018, BPD responded to the intersection of A Street and El Camino Real on a report of a disturbance. A report was generated and the case has been forwarded to the District Attorney's office for review.

On 03/04/2018, BPD conducted three separate traffic enforcement stops in Broadmoor and Daly City. Following an investigation, three drivers were arrested for driving while under the influence of alcohol or drugs.

On 03/04/2018, Corporal Yanga contacted a subject on Reiner Street and A Street. The subject was later placed under arrest after narcotics was located on his person.

On 03/07/2018, a tip jar was taken from the Subway restaurant located at 7800 El Camino Real. A suspect was later identified and the case has been transferred to the San Mateo District Attorney's Office for review.

On 03/08/2018, Officer Segali and Deputy Moore arrested for possession on a stolen vehicle along the 1600 block of Sweetwood Drive. The subjects also had outstanding arrest warrants from Solano County. The subjects were transported to county jail.

On 03/08/2018, two subjects were arrested for suspicion of operating a motor vehicle under the influence of alcohol or drugs, when they were contacted in traffic enforcement stops.

On 03/09/2018, BPD assisted the Colma Police Department with an impaired driver investigation.

On the night of 03/10/2018, BPD made three arrests on drivers for suspicion of operating a motor vehicle under the influence of alcohol, drugs, or both.

On the night of 03/11/2018, BPD arrested a subject for driving while under the influence of alcohol.

On 03/11/2018, Corporal Yanga and Officer Carriel contacted a subject who was seated in a parked vehicle at 310 A Street in Broadmoor. An investigation revealed the vehicle had been stolen several days prior on 03/08/2018. The subject was placed under arrest and later transported to County Jail.

On 03/12/2018, Corporal Yanga and Officer Carriel responded to Third Ave in Broadmoor on a report of a stolen vehicle. The vehicle was later located by the San Francisco Police Department and returned to the victim.

On 03/13/2018, Officer Logan conducted a traffic enforcement stop on a vehicle and found the driver to be unlicensed. The driver was cited and released at the scene.

On 03/13/2018, an attempted identity theft occurred. Luckily, the potential victim saw the unauthorized charges on his account and reported it to the police and his credit company.

On 03/14/2018, a package theft occurred on Village Lane. The suspects were observed taking the package off of a front porch, taking the contents, and then discarding the empty box on a nearby street.

On 03/15/2018, Officer Logan conducted a traffic enforcement stop and found the driver to be driving while under the influence of alcohol. The driver was ultimately arrested.

On 03/15/18, several vehicles were towed after they had not moved in more than 72 hours along A Street in Broadmoor.

On 03/15/2018, Officer Nguyen conducted a traffic enforcement stop on a vehicle and found the driver to be unlicensed. The driver was cited and released at the scene.

On 03/16/2018 and 03/17/2018, Officer Nguyen and Officer Landi conducted a traffic enforcement stop and found the driver to be driving while under the influence of alcohol. The driver was ultimately arrested.

On 03/19/2018, Officer Logan conducted a traffic enforcement stop and found the driver to be operating a motor vehicle with a suspended license. The driver was cited and released at the scene.

On 03/20/2018, Officer Espinosa responded to Reiner Street on a report of a stolen vehicle. A report was generated and the vehicle was later found in Pacifica.

On 03/23/2018, Officer Nguyen and Officer Landi issued a citation on a subject who was drinking in public for an open container.

Between 03/22 – 03/24, numerous vehicles were towed in Broadmoor after they had not moved in more than 72 hours. ***Vehicles are subject to tow if not moved within 72 hours.

On 03/24/2018, Officer Nguyen responded to an assault and battery that occurred at the Hillside Market. A report was generated and the case has been transferred to the District Attorney's Officer for prosecution.

On 03/25/2018, Officer Nguyen and Officer Landi conducted a traffic enforcement stop and found the driver to be driving while under the influence of alcohol. The driver was ultimately arrested.

On 03/25/2018, Officer Carriel responded to Reiner Street on a report of a petty theft. Video surveillance is being reviewed and the investigation is ongoing.

On 03/25/2018, Corporal Yanga and Officer Carriel made contact with an occupant of a suspicious vehicle. It was later discovered that the subject had an outstanding felony arrest warrant. The subject was placed under arrest and transported to County Jail.

On 03/25/2018, Corporal Yanga and Officer Carriel were dispatched to the Colma Fire Department on a report of a suspicious male. Upon contact, the subject began making incoherent statements. The subject was later transported to Mills Peninsula for psychiatric evaluation.

On 03/25/2018, Corporal Yanga, Officer Segali and Officer Carriel assisted the San Francisco Police Department with a homicide investigation.

On 03/26/2018, Officer Logan and Officer Segali responded to a report of a man holding a hammer on Reiner Street. The subject was later transported to Mills Peninsula for psychiatric evaluation.

On 03/27/2018, Officer Logan conducted a traffic enforcement stop and found the driver to be driving while under the influence of alcohol. The driver was ultimately arrested.

On 03/27/2018, Corporal Yanga and Officer Carriel made contact with two subjects at Colma Bart. A subject was ultimately placed under arrest after it was determined he was violating a restraining order.

On 03/27/2018, Corporal Yanga and Officer Carriel made contact with a subject near La Terraza Apartments, located at 7800 El Camino Real. It was later determined the subject had several misdemeanor warrants for his arrest. Officer's also later discovered narcotics.

On 03/27/2018, Corporal Yanga and Officer Carriel responded to Dave and Buster's on a report of a domestic violence incident that occurred in Broadmoor's jurisdiction. A report was generated and the suspect was ultimately found, placed under arrest and transported to County Jail.

On 03/28/2018, Officer Logan conducted a traffic enforcement stop and found the driver to be operating a motor vehicle with a suspended license. The driver was cited and released at the scene.

On 03/28/2018, Officer Segali responded to 85 Reiner Street on a report of a disturbance. It was later discovered that two subjects had gotten into an argument. A subject was placed under arrest for criminal threats and transported to County Jail.

On 03/29/2018, Deputy Moore conducted a traffic enforcement stop. A records check revealed the driver was operating a motor vehicle with a suspended driver's license and had two outstanding warrants for the same offense. The driver was placed under arrest and transported to County Jail.

On 03/29/2018, Officer Nguyen and Officer Landi conducted a traffic enforcement stop and found the driver to be operating a motor vehicle while under the influence of alcohol. The driver was placed under arrest.

On 03/30/2018, a vehicle was vandalized on Reiner Street and a case report was generated and provided to the victim.

On 03/30/2018, Officer Landi and Officer Nguyen contacted a subject near Colma Bart. Officers discovered narcotics on the subject's person and was placed under arrest.

On 03/31/2018, Officer Landi and Officer Nguyen assisted the Daly City Police Department with a suspicious person. Upon contact, Officers determined she was intoxicated. The subject was placed under arrest and transported to County Jail.

On 03/31/2018, Officer Nguyen and Officer Landi conducted a traffic enforcement stop and found the driver to be operating a motor vehicle while under the influence of alcohol. The driver was placed under arrest.

On 03/31/2018, the Broadmoor Police Department responded to a carjacking in process at 7500 El Camino Real. Upon arrival, the suspect was taken into custody and transported to County Jail on several felony charges.

On 03/31/2018, Officer Kniveton conducted a traffic enforcement stop near Hillside Boulevard and East Market Street. The driver was found to be operating a motor vehicle with a suspended license. The driver was arrested and later released.
