- B. Discuss and consider appointment of an Interim District Manager and an Interim Chief of Police. (Government Code §54954.5(e))
- C. Discuss and consider the process of filling the position of and appointing a permanent Chief of Police / District Manager. (Government Code §54954.5(e))

OPEN SESSION

- A. Report all reportable action, if any, taken in closed session.
- B. Discuss and consider reforming the District's management structure set out in Commissioners Policy Handbook section 2000.1, to separate the positions of District Manager and Chief of Police, and create two separate and distinct positions
 (i) DISTRICT MANAGER and (ii) CHIEF OF POLICE, with the District Manager reportable and answerable directly to the Commission, and the Chief of Police reportable and answerable directly to the District Manager.
- C. Reconfirm that an emergency arose on November 18, 2022, when the office of the Chief of Police became vacant at the general meeting on that date and an emergency agenda item was added at the end of the general meeting to appoint Commander John F. Duncan as Acting Chief of Police and reconfirm the emergency appointment. (Government Code § 54954.2(a)(1))
- D. Discuss and consider action to appoint an Interim District Manager.
- E. Discuss and consider action to appoint Acting Chief of Police John F. Duncan as Interim Chief of Police or appoint an Interim Chief of Police who will replace him.
